CPA Saint Laurent - REGISTRATION POLICIES

MEMBERS IN GOOD STANDING

All CPA Saint Laurent members must be members in good standing. This means that all fees including registration, coaching, test day, competition or other fees have been paid in full 5 days prior to registration.

MEMBERS IN ARREARS

Members in arrears will not be permitted to take part in any club activity and ice privileges will be revoked until monies are paid in full. Fees for tests, competitions, etc., must be paid prior to registration.

REGISTRATION PRIORITY

Members registered in the current Fall-Winter season are eligible to sign up for classes during the pre-registration period for the current Spring and Summer sessions. Members registered for the Fall-Winter 2023-2024 season are eligible to sign up during the pre-registration period for the Fall-Winter 2024-25 season. A skater who joined the club for a Spring or Summer session is not eligible to register during the pre-registration period. They can only register during the general registration period.

CONDITIONS

- 1) All prices and schedules are subject to change without notice.
- 2) The CPA Saint Laurent reserves the right to cancel any program in the event of insufficient registration.
- 3) The CPA Saint Laurent reserves the right to cancel a registration that includes a false declaration for their residence or to attestation of the skating skills of the skater. (i.e. A skater with skating skills badge 5 or above or who has passed a STAR test cannot register in a CanSkate Group, STAR Group Lesson or Adult Group class.) A processing fee of \$25 fee will be applied. The Skate Canada membership fee is non-reimbursable.
- 4) Cancellations and special activities associated with arena activities, acts of God (such as, but not limited to, fires, explosions, earthquakes, drought, tidal waves and floods); or borough related arena operations are not be eligible for a session replacement or reimbursement.
- 5) There are a limited number of places in all of our programs. We cannot guarantee availability in any class. Registration is on a first-come first-served basis.
- 6) Registrations must be completed on-line and must be completed in full to be accepted. Telephone or email registrations and reservations are NOT accepted.
- 7) The CPA Saint-Laurent processes registrations in the order they have been received on-line. Full payment must be made at the time of registration. Unpaid registration fees remaining after two (2) email notifications (15 days) after the on-line registration will result in the application of a processing fee of \$25.
- 8) **Late fees:** Spring: +20%, Summer School +10% (min \$10 for summer) will be applied for all registrations requested after the general registration.
 - **Administrative fees:** Request to modify a registration i) within 24 hours of completing the registration = \$5 ii) 24 hours after completing the registration and before the beginning of the session \$10 iii) after the session has begun \$20.
- 9) Low-income families who meet certain pre-established eligibility criteria can obtain a discount on the course fees. They must submit their supportive documentation obtained through the borough of Saint Laurent (green form) to the club via email 5 days before the date of registration. This rebate is only applicable for a basic Fall-Winter registration.
- 10) Sessions must be purchased as a complete unit; skaters are not allowed to purchase a partial session. The CPA Saint Laurent is not obliged to accept any registrations after the general registration deadline.
- 11) A skater cannot substitute or replace a session for which they have registered by another session. Note: a skater must purchase a "patch" to skate on another session. Skaters will not be permitted to buy an "ice patch" on any "sold-out" sessions regardless of whether there are "no shows". The club must be notified in advance to determine if there is room.
- 12) This season parents and skaters must read the PreSeason-Concussion-Education-Resource and attach with their registration or submit the acknowledgement form via email within 30 days of registration (i.e. October 5, 2024)
- 13) The Biblio carte-loisirs is an ID card for anyone who wishes to participate in activities offered by accredited nonprofit organizations of the Borough of Saint-Laurent. Any false declaration will result in suspension of carte- loisirs privileges. The Biblio carte-loisirs issued by the borough of Saint Laurent is free for residents and non-residents is mandatory.
- 14) Make-ups, credits, or refunds for missed classes (for any reason) are not available due to class schedules and ratios.
- 15) Skaters can retain their priority home club status for the 2024-2025 season if they register with the CPA Saint Laurent for the Fall -Winter 2024-2025 season in one of the following categories:

PRIVATE: New members who have or are assessed as badge 5 or higher at registration are not eligible to register with the club for the Fall-Winter 2024-2025 season. It is possible for skaters to register for the Spring 2025 or Summer 2025

- 16) Changes to the skater category is not possible after the close of the registration period. If the skater has passed a higher-level test level during the season; they still retain the same category established at the time of validation of the registration.
- 17) MAXIMUM NUMBER OF SESSIONS:
 - a. GROUP (CANSKATE): Maximum of three sessions (CanSkate, CanSkate lesson, dev). / b. PRIVATE: Maximum 5 sessions (STAR group lesson, dev).

CREDIT / REFUND POLICIES

No cash refunds will be given. Credits and refunds will not be considered after half the classes have occurred except for medical reasons (doctor's certificate required). Make-ups, credits, or refunds for missed classes (for any reason) are not available due to class schedules and ratios.

A full credit will be issued for all requests made prior to the start of a program. The Skate Canada membership fee (\$64) is not reimbursable. An administrative fee of \$25 will apply.

No credits will be issued after the registration deadline. Medical cancellations requested after the program has started and before half of the classes have occurred must be made in writing (email to the club) accompanied by a medical certificate, the amount credited will be proportionate to the number of lessons remaining in the program minus the cancellation fee.

To obtain the maximum discount, registrations must be completed in a single transaction. Multiple transactions will not benefit from the discounted rate.

Reimbursement

A service charge (\$25 Fall / Winter and Summer School, \$10 Spring) will be applied to all requests for refunds.

- The mandatory Skate Canada registration fee is not reimbursable and will be deducted from all reimbursement.
- Refund requests must be submitted in writing indicating the reason for withdrawal. Supporting documentation must be provided. The board members of the Saint-Laurent figure skating club will review the request. All decisions are final
- The club will issue a cheque or credit to the account 2 to 4 weeks following the decision.

TRANSFERS

Requests for transfers will be considered for:

Fall-Winter 2024: up to September 30, 2024. A fee of \$10 will apply for requests received before the first session.

Once the season has begun, administrative fees of \$15 will apply for all requests to change sessions per skater. All requests for transfers made after this date will be refused.

CONDITIONS

Payment or credit will not be made for refunds of \$10 or less (after deduction of the administration charge).

**Please note that NEW registrations for private lessons received by mail or deposited at the club office before the first day of registration for NEW MEMBERS will not be considered. All registrations must be completed on-line.
